

ORDINANCE 2007-06

AN ORDINANCE OF THE CITY OF FULTON, KENTUCKY, INCREASING WATER AND SEWER RATES FOR THE CITY AND WATER DISTRICT; REPEALING ANY CONFLICTING ORDINANCES; AND PROVIDING FOR EFFECTIVE DATES

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF FULTON, KENTUCKY AS FOLLOWS, TO-WIT:

SECTION ONE:

(A) That the rates for water service per gallon for all water customers located inside the city limits of the City of Fulton, Kentucky are hereby established as follow:
