

**AMENDED RATE ORDINANCE**

**AN ORDINANCE OF THE CITY OF KEVIL, KENTUCKY, REVISING THE RATES AND CHARGES FOR THE USE OF AND THE SERVICE RENDERED BY THE WATER SYSTEM OF THE CITY.**

WHEREAS, the City Council of the City of Kevil, Kentucky (the "City"), is in the process of arranging to finance the construction of certain extensions, additions and improvements to the existing water system (the "System") of the City, and

WHEREAS, it is necessary in connection with said plan of financing that the existing monthly water rates be increased,

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEVIL, KENTUCKY, AS FOLLOWS:**

**Section 1. Revised Monthly Water Rates.** That the monthly rates and charges for water service furnished by the City are hereby revised as follows:

**IN-TOWN:**

First 2,000 gallons @ \$6.75 - Minimum Bill.  
All Over 2,000 gallons @ \$1.70 - per 1,000 gallons

**OUT-OF-TOWN:**

First 2,000 gallons @ \$8.10 - Minimum Bill.  
All Over 2,000 gallons @ \$2.05 - per 1,000 gallons

**FORMER BANDANA WATER DISTRICT CUSTOMERS**

First 3,000 gallons @ \$13.94 - Minimum Bill.  
Next 2,000 gallons @ \$ 4.40 - per 1,000 gallons  
All Over 5,000 gallons @ \$ 4.10 - per 1,000 gallons

**Section 2. Severability.** That if any clause, provision, paragraph or section of this Ordinance be ruled void or unenforceable by any court of competent jurisdiction, the remainder thereof is intended to be enacted and shall be in full force and effect notwithstanding.

**Section 3. All Former Provisions in Conflict Repealed; Effective Date of Ordinance.** That all orders, ordinances, motions or parts thereof, insofar as same may be in conflict herewith, are repealed, and this Ordinance shall take effect from and after its passage, approval and publication as provided by law.
