RULES AND REGULATIONS

This schedule of Rules and Regulations governs the furnishing of water service by SEDALIA WATER DISTRICT herein after referred to as the Utility and applies to all service received from the Utility. No employee or individual director of the Utility is permitted to make an exception to Rates, Rules or Regulations. All Rules and Regulations are to be in effect so long as they are not in conflict with Public Service Commission Rules and Regulations. The Utility is further subject to all Rules and Regulations of the Commission even though not contained herein.

REVISIONS

These Rules and Regulations may be revised, amended, supplemented or otherwise changed from time to time subject to approval of the Public Service Commission, and shall have the same force as the present Rules and Regulations.

SERVICE AREA

The Utility furnishes water service to all residences and businesses and churches located at Sedalia in Graves county Kentucky.

AVAILABILITY

Water Service is available to any domestic, commercial or industrial consumer within the Utility's area.

WATER FAILURE

The Utility is responsible for water failure only when in control of the Utility's employees. No consumer is paid damages for equipment unless such damages are specifically found to be caused by an act of negligence on the part of the Utility or its employees.

PROTECTION BY CONSUMER

Consumer shall protect the equipment of the Utility on his premises and shall not interfere with Utility's property or permit interference except by duly authorized representatives of the Utility.

RULES AND REGULATIONS

NOTICE OF TROUBLE

Consumer shall give immediate notice to the Utility of any irregularities or unsatisfactory service and of any defect know to consumer.

MAINTENANCE

The Utility may at any time deemed necessary, suspend sewer service to any consumer or consumers for the purpose of making repairs, changes or improvements upon any part of its system. The Utility shall give reasonable notice of such suspension of service to the consumer.

The Utility shall be responsible for the maintenance of that portion of the service line installed by the Utility and the consumer shall be responsible for the maintenance of that portion thereof installed by the consumer.

EXTENSIONS OF SERVICE

Extension of service shall be in accordance with 807 KAR 5:066 , Section 14.

LINE RELOCATIONS

When necessary to move or relocate facilities, the cost will be paid by party or parties requesting such relocation.

BILLING, COLLECTION, PENALTIES

Bills for water service furnished by the water system will be mailed no later than the 25th day of each month and will be due and payable within _____ days (or by the 10th day of the following month). A 10 % late penalty charge will be applicable after the due date of any account.

RULES AND REGULATIONS

DEPOSITS

The Utility may require from any customer or applicant for service a cash deposit or other guaranty to secure payment of bills not to exceed two-twelfths (2/12) of the estimated annual bill of such customer or applicant where bills are rendered monthly, or three-twelfths (3/12) of the estimated annual bill where bills are rendered bimonthly, or four-twelfths (4/12) of the estimated annual bill where bills are rendered quarterly. Interest will be paid as set out in 807 KAR 5:006, Section 7(6), and KRS 278.460(2).

DISCONTINUANCE OF SERVICE BY UTILITY

The Utility may refuse or discontinue service to an applicant or customer, after proper notice, for failure to comply with its rules and regulations or state and municipal rules and regulations, when a customer or applicant refuses or neglects to provide reasonable access to the premises, for fraudulent or illegal use of service, or for nonpayment of bills. If discontinuance is for non-payment of bills, the customer shall be given at least 5 days written notice, separate from the original bill, and cut-off shall be effected not less than twenty (20) days after the mailing date of the original bill unless, prior to discontinuance, a residential customer presents to the utility a written certificate, signed by a physician, registered nurse, or public health officer, that such discontinuance will aggravate and existing illness or infirmity on the affected premises, in which case discontinuance may not be effected until the affected resident can make other living arrangements or until not less than ten (10) days elapse from the date of the Utility's notification. When a dangerous condition is found to exist on the customer's or applicant's premises, the service shall be cut off without notice or refused.

SPECIAL CHARGES

Special Reading Charge

A special reading charge of \$10.00 may be assessed when a customer requests that a meter be reread and the second reading shows the original reading was correct. No charge shall be assessed if the original reading was incorrect.

Returned Check Charge

A returned check charge of \$10.00 may be assessed if a customer's check is returned for insufficient funds by his bank.

Meter Test Charge

A meter test charge of \$20.00 may be assessed if a customer requests that the meter be tested and the tests show the meter is not more than two percent (2%) fast. If the meter is more than two percent (2%) fast no charge will be made. The utility shall make a test upon written request of any customer. The meter will only be checked once annually for any one customer.

Turn on Charge

A turn on charge of \$15.00 will be assessed for new customers.

Reconnect Charge

A reconnection charge of \$30.00 will be assessed to reconnect service that has been terminated for non payment of bill.

Field Collection or Payment Delay Charge

Field collection fee will be \$15.00. A field collection charge may be assessed when utility personnel makes a trip to premises of a customer to collect bill. The charge may also be made if cut off is delayed based on payment to be received by certain date
